



Declaration of Conformity

REGULATION EC No. 1907/2006

The REGULATION EC No. 1907/2006 OF THE EUROPEAN PARLIAMENT AND OF THE COUNCIL has been in force since 01.06.2007 and regulates registration, evaluation, authorization and restriction of chemicals in Europe (REACH).

It aims to ensure a high level of protection for human health and environment and to ensure the free movement of substances on their own, in preparations or in products, while improving competitiveness and innovation.

Part of the regulation is the general obligation to register substances and preparations as well as - under certain conditions - products. The grinding tools supplied by us are complex objects (products) in the sense of the regulation. They do not contain substances intended to be released under normal or reasonably foreseeable conditions of use. According to Article 33 of the REACH Regulation, every supplier of a product is obliged to inform if substances of very high concern (so-called SVHC) above 0.1% (mass percent) are contained in the article.

The European Chemicals Agency ECHA publishes a list of these SVHC (so-called candidate list), which is updated and supplemented every six months. We follow the updates of this list very closely and are in close exchange with our suppliers on this. If we become aware that our products (including packaging) contain SVHC substances in a corresponding concentration, we inform our customers without being asked.
